MEMORANDUM OF UNDERSTANDING

Between

**MOULOUD MAMMERRI UNIVERSITY OF TIZI OUZOU,
ALGERIA**

And

UNIVERSITÀ EUROPEA DI ROMA, ITALY

First article: PREAMBLE

This Memorandum of Understanding ("MoU") is effective between University of Mouloud Mammeri of Tizi-Ouzou, Algeria (hereafter referred to as UMMTO) and Università Europea di Roma, Italy (hereafter referred to as UER). UER and UMMTO hereby agree on the following terms and conditions with the objective of promoting and expanding international understanding by stimulating and supporting educational, professional and intercultural activities and projects among students and staff of the two institutions and the respective communities that support them. The two parties may engage in the following areas of cooperation:

- Visits and exchange of members of the University and staff for the purpose of teaching, research and sharing best practices;
- Collaborative research projects and joint initiatives such as seminars and lectures;
- Exchanging publications and other material of common interest;
- Admission of UMMTO students to Università Europea di Roma.

This Memorandum of Understanding (hereafter referred to as MoU) is not intended to create any legally binding obligations on either party. Nothing herein, therefore, shall diminish the full autonomy of either institution.

University of Mouloud Mammeri of Tizi-Ouzou (UMMTO) will oversee informing students about study abroad opportunities at Università Europea di Roma (UER) for the duration of the cooperation and providing support with additional information and the application process.

Article 2: DURATION OF AGREEMENT

This MoU will be effective from the date of signing by both parties for five years. Either party may terminate this MoU by giving ninety (90) days prior written notice to the other party by personal delivery or courier to the attention of the party's representative below.

Article 3: PERIOD OF STUDY

UMMTO students will be eligible to enroll at UER as study abroad students, typically during one or two semesters.

Article 4: ELIGIBILITY

UER will consider the admission of all students nominated by UMMTO subject to acceptance of their qualifications and availability of places in their chosen subjects.

Article 5: INITIALS CREENING

UMMTO will review applications to ensure that students nominated to UER are of a suitable academic standard. UMMTO students will provide the required documentation.

Article 6: SUBMISSION OF APPLICATIONS

UMMTO will ensure that the applications of its nominees to UER are received within the established terms. UER will send application decisions to the applicants and to UMMTO.

Article 7: ACCESS TO FACILITIES

UMMTO students will have access to all the academic, social, health and welfare facilities available to UER students.

Article 8: CREDIT AND CREDIT TRANSFERS

The Transcript of Records issued by UER at the end of the study period will show the course grades and details of the grading system. It shall be the sole responsibility of UMMTO to determine the credit value and grade equivalency that their students may actually receive for their academic work at UER.



Article 9: HOUSING

UMMTO students will be provided by UER IR Office with instructions on how to book UER housing on-campus and off-campus once accepted to the program.

Article 10: ACADEMIC AND DISCIPLINARY REGULATIONS

All students attending UER shall be subject to the same academic and disciplinary regulations and policies as pertain to all other UER students. UER agrees to inform UMMTO students of such academic and disciplinary regulations.

Article 11: COMPLIANCE WITH AND ABIDING BY LOCAL LAWS

Each Party agrees that, in connection with this MoU, it will take no action, or omit to take any action, which would cause to the other party to be in violation of the applicable laws in Algeria or in Italy.

Violation of local laws in Italy may subject the student to expulsion from UER.

Article 12: FINANCIAL ARRANGEMENTS

UER tuition fee payments will be made by UMMTO for the accepted UMMTO students after receiving the invoice of UER in accordance with the deadlines and rules detailed on UER website under "Study programmes>Free movers — Study Abroad":

Participating students must be responsible for travel to/from the host country and bear housing and all living expenses. If required or needed, they also have to purchase medical insurance to cover medical contingencies in the host country. Neither UER nor UMMTO shall be held liable for such charges.

Article 13: NON-DISCRIMINATION

Neither Party will discriminate on the basis of race, sex, age, national origin, color, religion, sexual orientation or disability.

Article 14: USE OF NAMES

Each Party shall control the use of its names including associated trademarks and service marks. Neither Party shall use the name or marks of the other in any press materials, or web-based or other publication, without the prior written permission of the other, however, that each may include the name of the other on any routinely maintained published list of partner universities during the term of this MoU.

Article 15: FORCE MAJEURE

The provisions of this MoU may be suspended by an occurrence or circumstances beyond their control of either Party, including, without limitation, acts of God, war, terrorism, industrial disputes, fire, flood, tempest and national emergencies.

Article 18: BENEFIT

This MoU is intended solely for the benefit of UMMTO and UER. There is no intention to create any rights or interest for any party or person other than UER or UMMTO.
